ORDER UNDER SECTION 144 Cr.P C

Whereas, there is spread of Covid-19 in different parts of the District which poses a major threat to public health, hygiene and safety of the people and it is also felt that unless measures are put in place to contain the spread of the pandemic, there is chance of large scale spread of COVID-19 in the population which is likely to cause loss of human lives.

AND

Whereas the COVID-19, in its 2nd wave, is spreading very rapidly throughout the country. In Tripura, new cases of COVID 19 are also being detected every day in increasing numbers. The Majority of the cases are in Agartala Municipal Corporation (AMC) area. The matter has been reflected in the order of the Chief Secretary, Government of Tripura vide Order No. F.2(1)/CS/Home/2020 dated 20th April, 2021;

AND

Whereas, I Dr. Shailesh K. Yadav, IAS, District Magistrate & Collector, West Tripura District, am fully satisfied that immediate prevention and speedy remedy is desirable and that there is sufficient ground for imposing restrictions on movement in AMC area of West Tripura District to prevent danger to Public health & human life.

Now therefore, I, Dr. Shailesh K. Yadav, IAS, District Magistrate & Collector, West Tripura in exercise of the powers conferred upon me under **section 144 Cr. P.C, 1973** do hereby order the enforcement of the following prohibitory measures:

Corona Night Curfew

- 1) Corona night curfew is hereby imposed between 10 P.M. to 05 A.M. everyday in Agartala Municipal Corporation area w.e.f. 10 PM of 22nd April, 2021 till 05 AM of 01st May, 2021.
- 2) Any gathering or movement of individuals & vehicles shall remain strictly prohibited between 10.00 PM (night) to 05:00 AM (morning) .
- 3) Functioning of Shops, Offices, Marriage halls, Restaurants, Cinema halls, gymnasium, swimming pools, entertainment parks, theatres, bars and auditoriums, assembly halls and similar places are prohibited during the said night curfew hours.
- 4) Social/Political/sports event/entertainment/academic /Cultural/religious functions/ other gatherings of all kinds within Agartala Municipal Corporation area are prohibited during the said night curfew hours.

Exemption from Night curfew

- 1) Hospitals, Pharmacies, Pathological/Radiological laboratories.

- 2) Movement of Military/paramilitary Force and State Police personnel engaged in maintenance of Law and Order.
- 3) Movement of patients requiring medical treatment.
- 4) Movement of Government employees with valid Identity card to maintain essential services like Health services, General Administration, power supply & drinking water supply
- 5) Movement of Municipal Vehicles & staff on duty during the night.

Any person violating these prohibitory measures shall be liable to be prosecuted under section 188 of IPC and other legal provisions in force.

In view of the emergent nature of situation and with a view to ensure public health & safety this order is passed ex-parte & is addressed to public in general

The Superintendent of Police, West Tripura shall take necessary measure to strictly enforce the above order.

The order shall be widely promulgated by the Director, ICA, Government of Tripura through electronic media & local daily newspapers.

The Municipal Commissioner AMC & the Sub-Divisional Magistrate, Sadar, West Tripura shall ensure the publicity of this order through miking within the Agartala Municipal Corporation Area.


