ORDER UNDER SECTION 144 Cr.P C

Whereas, it has been ordered by the Chief Secretary, Government of Tripura vide order No.F.2(1)/CS/Home/2020 dated 3rd May, 2021 that the Corona Night Curfew will be imposed in the areas of Agartala Municipal Corporation (AMC), Ranirbazar Municipal Council, Mohanpur Municipal Council and Jirania Nagar Panchayat between **6 P.M. to 5 A.M. w.e.f 4th May, 2021 up to 31st May, 2021;**

AND

Whereas, there is spread of Covid-19 in different parts of the District which poses a major threat to public health, hygiene and safety of the people and it is also felt that unless measures are put in place to contain the spread of the pandemic, there is chance of large scale spread of COVID-19 in the population which is likely to cause loss of human lives;

AND

Whereas, the COVID-19, in its 2nd wave, is spreading very rapidly throughout the country. In Tripura, new cases of COVID-19 are also being detected every day in increasing numbers. The Majority of the cases are in the areas of Agartala Municipal Corporation (AMC), Ranirbazar Municipal Council, Mohanpur Municipal Council and Jirania Nagar Panchayat under West Tripura District;

AND

Whereas, I, Sri Raval Hamendra Kumar, IAS, District Magistrate & Collector, West Tripura District, am fully satisfied that immediate prevention and speedy remedy is desirable and that there is sufficient ground for imposing restrictions on movement in the areas of AMC, Ranirbazar Municipal Council, Mohanpur Municipal Council and Jirania Nagar Panchayat of West Tripura District to prevent danger to Public health & human life;

Now therefore, I, Sri Raval Hamendra Kumar, IAS, District Magistrate & Collector, West Tripura in exercise of the powers conferred upon me under **section 144 Cr. P.C, 1973** do hereby order the enforcement of the following prohibitory measures:

Corona Night Curfew

1. Corona night curfew is hereby imposed between **6 P.M. to 5 A.M.** every day in the areas of Agartala Municipal Corporation, Ranirbazar Municipal Council, Mohanpur Municipal Council and Jirania Nagar Panchayat.w.e.f. **4th May, 2021 till 31st May, 2021.**
2. Any gathering or movement of individuals & vehicles shall remain strictly prohibited between **06.00 P.M. (evening) to 05:00 AM (morning).**
3. Functioning of Shops, Offices, marriage halls, Restaurants, Cinema halls, gymnasium, swimming pools, entertainment, theatres, bars and auditoriums, assembly halls and similar places are prohibited during the said night curfew hours.
4. Social/Political/sports event/ entertainment/ academic /cultural/fair/festival related congregations/religious functions/ other gatherings of all kinds within areas of Agartala Municipal Corporation and all Urban Local Bodies are prohibited during the said night curfew hours.

Exemption from Night curfew

- 1) Hospitals, Pharmacies, Pathological/Radiological laboratories.
- 2) Movement of Military/ Paramilitary Force and State Police personnel engaged for maintenance of Law and Order.
- 3) Media Persons having valid identity card and on news coverage duty.
- 4) Movement of patients requiring medical treatment.

- 5) Movement of Government employees with valid Identity card to maintain essential services like Health services, General Administration, fire & emergency service, jail, social welfare, homes, power supply & drinking water supply.
- 6) Movement of Municipal Vehicles & staff on duty during the night.
- 7) Movement of goods including petroleum products and loading and unloading of cargo.
- 8) Movement of persons for operation of industrial units in multiple shifts & continuous operation.
- 9) Travel of persons to their destinations after disembarking from buses, trains and aeroplanes.
- 10) **Marriage in marriage halls/ own homes up to 10 P.M. with maximum 50 guests are allowed.**

Any person violating these prohibitory measures shall be liable to be prosecuted under **section 188 of IPC** and other legal provisions in force.

In view of the emergent nature of situation and with a view to ensure public health & safety this order is passed ex-parte & is addressed to public in general.

The Superintendent of Police, West Tripura shall take necessary measure to strictly enforce the above order.

The order shall be widely promulgated by the Director, ICA, Government of Tripura through electronic media & local daily newspapers.


