ORDER

In supersession of previous orders issued in this regard and in exercise of powers u/s 50 of Disaster Management Act, 2005 already delegated vide order No. 52/DGHS/PH-IV/COVID-19/2020/prsecyhfw/ 144400-14449 dated 20.06.2020, Medical Directors/ Medical Superintendents/ Directors of all COVID Hospitals of Government of NCT of Delhi are allowed to requisition following medical manpower to augment the capacity to manage critically ill patients at the remuneration indicated against each post u/s 65 & 66 of Disaster Management Act, 2005.
