**Subject: - Imposition of COVID Curfew in Leh district regarding.**

**ORDER**

**WHEREAS**, the Secretary MoHFW, G.O.I vide D.O No. Z.28015/85/2021-DM Cell Dated 25.04.2021 has advised all District Magistrates to undertake containment measures to restrict intermingling amongst people so that spread of infection can be controlled.

**WHEREAS**, detailed assessment of the current COVID situation in Leh district has been conducted by the DDMA, Leh in light of continuous surge in COVID cases, Positivity Rate, and Hospital admissions etc., and are of the clear view that extension of restrictions is needed to avoid further spread of the Corona Virus.

**NOW THEREFORE**, in view of the above, I, Shrikant Balasaheb Suse, IAS, District Magistrate, Leh in exercise of the power conferred upon me as Chairman, District Disaster Management Authority under section 34 of Disaster Management Act 2005 as well as under Section 144 CrPC, 1973, Epidemic Disaster Management Act, 1897, and in partial modification of this office order issued vide No. DCL/PS/COVID-19/OO/2021-1166 Dated 16.05.2021, hereby order that:

1. All Movement passes issued by this office till date shall stand withdrawn with immediate effect.
2. No public dealing shall be allowed in all Govt. offices with effect from 22.05.2021 and all Govt. offices shall adopt virtual mode of meeting, avoiding any kind of physical meeting till further order.
3. **There shall be complete restriction on Weekends i.e Saturday & Sunday, on all kind of Activities/Movements (except those mentioned in the Annexure "A" to this order), including all Govt. offices w.e.f 7 AM of 22.05.2021.**
4. There shall be complete restriction on all kind of Movements/Activities on weekdays across Leh district from 24.05.2021 (Monday) 7 AM to 07.06.2021 (Monday) 7 AM, with the following permissible Activities/Movements.
  - i. All Govt. Employees of UT Government/G.O.I/PSUs, Autonomous bodies, Universities, Banks, and Airport Staff shall be allowed to commute to/from office from 9 AM to 10:30 AM and from 4 PM to 5:30 PM, on production of valid Identity Cards along with Colour Coded Duty roster which shall be pasted on the front windscreen of the vehicle.
  - ii. All Grocery/General Stores, Vegetable/Fruit shops and stores, Meat/Chicken Shops, Fuel retailers/Depots, Milk/Dairy Product Shops, Bakeries, and Tyre Puncture repair shops shall be allowed to open from 7 AM to 11 AM within the locality, with restriction on movement of Shop Owners and public from one locality to another. Supply for Whole-sellers and Distributors shall be allowed between 5 AM to 8 AM and their movement shall be allowed on production of valid Trade License/Registration Certificate. No separate permission is required for the same.

- iii. Transportation of Vegetables, Perishables, and Fuel items from outside district shall be allowed on production of relevant proof.
- iv. All Judicial officers/officials/staff of all courts in the district on production of valid identity Card and/or duty roster.
- v. Medical Services, Hospitals, Chemist Shops, Diagnostic Centers, Medical & Clinical Establishments and Private Security Services etc.
- vi. Officials on duty for Water, Electricity, Sanitation Services, Public Works, Fire brigade, Telecom Service Providers (Airtel/Jio/BSNL), Print & Electronic Media persons, ATM operators etc. on production of valid Identity Cards with Movement Pass issued by this office.
- vii. Armed Forces/Paramilitary Forces.
- viii. The beneficiaries of the COVID vaccination & sampling shall be allowed on the production of online registration ID.
- ix. The passengers including Tourists travelling **to/from** outside Leh district by Air shall be allowed to commute on the production of boarding passes/Air Tickets; and only a limited no. of Taxis/Mazda Buses with prior permission of the office of the District Magistrate, Leh shall be allowed to ply.
- x. All Leh bound vehicles including the Load carriers/Commercial taxis coming from outside district shall be allowed with strict compliance of COVID-19 SOPs of UT/District Administration.

The Sr. Superintendent of Police, Leh and Chief Executive Officer, DDMA (Addl. District Magistrate, Leh), ARTO, Traffic Police, Sub Divisional Magistrates, Executive Magistrates 1st class, COVID SOPs Enforcement Squads shall ensure implementation of the above directives in letter and spirit.

- x. All Leh bound vehicles including the Load carriers/Commercial taxis coming from outside district shall be allowed with strict compliance of COVID-19 SOPs of UT/District Administration.

The Sr. Superintendent of Police, Leh and Chief Executive Officer, DDMA (Addl. District Magistrate, Leh), ARTO, Traffic Police, Sub Divisional Magistrates, Executive Magistrates 1st class, COVID SOPs Enforcement Squads shall ensure implementation of the above directives in letter and spirit.

**Any violations of these orders shall invite action under Section 188 of IPC, Disaster Management Act, 2005 and Epidemic Disease Act 1897.**
