ORDER

Whereas, the Government of Assam in Health & Family Welfare Department, vide order No. HLA.264/2020/5 dated 17/05/2021, had allowed Home Isolation for certain categories of COVID-19 positive patients subject to adherence to certain guidelines;

Whereas, it is seen that some patients with co-morbidities under Home Isolation have had serious medical issues during Home Isolation, and had to be admitted to Medical Institutions at a later stage;

Now, therefore, in partial modification of the order referred to above, it is hereby instructed that **all COVID-19 positive patients with co-morbidities, irrespective of age, shall have to mandatorily undergo Institutional Isolation.**

This order will come into effect immediately.
