

Order

Whereas, vide order No. DMC-SPO-2020/5215, dated 02.05.2021, the State Executive Committee had declared a lockdown from 03.05.2021 (05:00 am onwards) to 10.05.2021 (till 05:00 am) in the State of Haryana and the same was extended as "Mahamari Alert-Surakshit Haryana" (महामारी अलर्ट-सुरक्षित हरियाणा) vide various orders issued earlier.

Further, the State Executive Committee has extended the "Mahamari Alert-Surakshit Haryana" (महामारी अलर्ट-सुरक्षित हरियाणा) vide order No. DMC-SPO-2020/6222 dated 06.06.2021 for another week i.e. from 07.06.2021 (05.00 am onward) to 14.06.2021 (till 05.00 am) in the state of Haryana along with guidelines issued earlier with following relaxations are provided in modification of earlier orders issued:-

- a. Shops other than stand-alone shops are allowed to open from 09.00 A.M. to 06.00 PM in two groups namely odd and even-shops with odd numbers on odd dates and shops with even number on even dates.
- b. Malls are allowed to open from 10.00 AM to 06.00 PM.
- c. Restaurants and bars (including in hotels and in malls) are allowed to open from 10.00 AM to 08.00 PM with 50% of the seating capacity and adopting requisite social distancing norms, regular sanitisation and Covid appropriate behavioural norms. Home delivery from hotels, restaurants and fast food joints is permitted upto 10.00 PM.
- d. Religious places are allowed to open with 21 persons at one time with the condition that they follow requisite social distancing norms, regular sanitisation and Covid appropriate behavioural norms.
- e. Corporate Offices are permitted to open with 50% attendance after adopting requisite social distancing norms, regular sanitisation and Covid appropriate behavioural norms.
- f. Gathering in weddings, Funerals/Cremations are allowed upto 21 persons. However wedding can take place at place other than home and Courts also. No movement of "Barat" procession will be allowed.
- g. For gathering other than wedding, funerals/cremations, the maximum number allowed will be 50. For gatherings more than 50, prior permission from the Deputy Commissioner shall required.
- h. Club houses/restaurants/bars of the Golf Courses are allowed to open with 50% seating capacity from 10.00 AM to 08.00 PM with adherence to requisite social distancing and other safety norms. Members/visitors shall be allowed to play in Golf Courses by the management in a staggered manner so as to avoid overcrowding.

Hence, I, Ajay Kumar, IAS, District Magistrate-cum-Chairperson, District Disaster Management Authority, in exercise of the powers conferred under section 30 of the Disaster Management Act, 2005, do, hereby, order that the Superintendent of Police, Incident Commanders, Duty Magistrates, and officials of all concerned departments shall ensure strict compliance of the above mentioned orders and the orders issued by this office vide memo No. 335/MA dated 02.05.2021 (Annexure "A"), 363/MA dated 09.05.2021 (Annexure "B"), 414/MA dated 16.05.2021 (Annexure "C"), 465/MA dated 23.05.2021 (Annexure "D") and 512/MA dated 30.05.2021
